

ARDUINO USER COMMUNITY GIVEAWAY TERMS AND CONDITIONS

NO PURCHASE NECESSARY TO ENTER OR WIN IN THE ARDUINO USER COMMUNITY SURVEY GIVEAWAY (THE “PROMOTION”).

A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

SPONSOR: Arduino S.r.l. (“Sponsor”)

WHO MAY ENTER:

This Promotion is open to eligible entrants (collectively referred to hereafter as “you” or “Entrant”) who meet the following requirements at time of entry:

- You are at least 18 years of age, or the minimum age of majority in your place of residence at the time of entry.
- You are a citizen of and reside in any country **except**: Cuba, Iran, North Korea, Syria, Russia, Belarus, Sudan/South Sudan, Yemen, Venezuela, Burma (Myanmar), Libya, Afghanistan, Central African Republic, Palestine, Democratic Republic of the Congo, Iraq, Somalia, Ethiopia, and Russian-occupied regions of Ukraine (Crimea, Donetsk People's Republic, Kherson, Luhansk People's Republic, Zaporizhzhia).
- You are not: (i) an employee of Sponsor or its parent companies, affiliates and/or subsidiaries; (ii) an immediate family member or household member of an employee of Sponsor or its parent companies, affiliates and/or subsidiaries; and (iii) otherwise involved in the execution or administration of this Promotion.
- You are not a “Restricted Person”, which is defined as any legal or natural person (i) listed on a prohibited or restricted party list published by the U.S. government, including but not limited to the U.S. Department of Treasury’s “List of Specially Designated Nationals and Blocked Persons” and “Consolidated Sanctions List”, and the U.S. Department of Commerce’s Entity List, Unverified List, Denied Persons List, and Military End-User List, or any similar list maintained by the United Kingdom, the European Union or its Member States, or other applicable local authority; (ii) located, organized or resident in a country or territory against which the U.S. government maintains comprehensive economic sanctions or an embargo (i.e., currently Cuba, Iran, North Korea, and the Crimea and other regions of Ukraine controlled by the Russian Federation); (iii) in the case of a legal person, owned (50% or more in the aggregate) or controlled, directly or indirectly, by one or more persons or entities described in (i) or (ii); or (iv) otherwise the target of U.S. sanctions (collectively, “Restricted Persons”).

BY PARTICIPATING IN THE PROMOTION, EACH ENTRANT REPRESENTS AND WARRANTS THAT HE OR SHE MEETS THE ELIGIBILITY REQUIREMENTS STATED IN THESE TERMS AND CONDITIONS (“T&Cs”) AND ACKNOWLEDGES THAT FAILURE TO MEET ALL ELIGIBILITY REQUIREMENTS WILL DISQUALIFY ENTRANT FROM THE PROMOTION.

Point (i) (above) is referred to hereafter as your "Entry." Limit one (1) Entry per Entrant. If more than one (1) Entry is received from an individual, only the first Entry received will be considered eligible for the Promotion. Normal Internet access and data usage charges imposed by online and cell phone service provider may apply. By submitting your Entry, you hereby represent that you have all rights necessary to submit the Entry and to grant to Sponsor the rights set forth herein.

Tampering with the entry process or the operation of the Promotion, including, but not limited to the use of any device to automate the entry process, is prohibited and any entries deemed by Sponsor, in its sole discretion, to have been submitted in this manner will be void.

Subject to relevant laws, Entrant agrees to notify Sponsor of any violation of this section that has or may have occurred.
